Dear Valued Customer,

Perrigo Direct has been notified by one of our suppliers, KC Pharmaceuticals, of a **retail level recall** of **GoodSense® Eye Drops** due to potential concerns regarding the validation of the Company's aseptic filling process for the period between March 27, 2024, and November 07, 2024. Use of this product may result in eye infection.
